NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Notification No.F.5/4/65-GP, dated the 11th January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in partial modification of the Directorate of Art & Culture, Government of Puducherry Notification issued in G.O.Ms.No. 48, dated 2nd December, 2014 and published as a supplement to the Gazette No. 30 of the 25th July, 2017, the Lieutenant-Governor, Puducherry hereby makes the following rules further to amend the rules regulating the method of recruitment column (10) and the column (11) to the Group 'C' (Non-Gazetted - Non-Ministerial) post of Junior Library Attendant in the Directorate of Art and Culture, Government of Puducherry, namely:-

1. *Short title and commencement.*- (i) These rules may be called the Government of Puducherry, Directorate of Art and Culture, Group 'C' (Non-Gazetted - Non-Ministerial) post of Junior Library Attendant Recruitment(Amendment) Rules, 2019.

(ii) They shall come into force on and from the date of their publication in the official gazette.
