ORDER:

In the G.O. 1st read above, sanction of the Lieutenant Governor was accorded for incurring an expenditure for an amount of Rs. 2,49,183/- towards the engagement of 11 nos. of private security for carrying out works of watch and ward security and other work of this kind arise as and when in the premises of Puducherry Museum, Bharathiar Manimandapam, Kizhoor Monument and V. Subbaiah Museum, Puducherry for the period of three months from 01.04.2018 to 30.06.2018 at the rate of Rs. 7,551/- (Inclusive of ESI, EPF & GST) per person per month from M/s Kalai Industrial Security Services, No.46, Arappani Avai Thottam, Nethaji Nagar-III, Uppalam Road, Puducherry-1 on lowest quotation basis.

- 2. In the I.D.Note 2nd read above, instructions were issued to procure all common use Goods and Services through Government e-market Place in accordance with Rule 149 of G.F.R, 2017, with the approval of competent authority to whom the power of such procurement has been delegated. As per rule 183(ii) of G.F.R. 2017, the total estimated cost exceeds Rs.25.00 lakhs, the services shall be called on Central Public Procurement Portal (CPPP) and GEM Portal. Therefore, the bid has been called for the engagement of 56 nos. of House Keeping / Watch and Ward Security personnel through Gem Portal for the use of all buildings under the Directorate of Art and Culture, Puducherry. Out of the nine service providers participated in the bidding, M/s. Kalai Industrial Security Service, Puducherry has qualified in Technical evaluation / financial evaluation and awarded as L1 bidder.

Expost facto Expenditure Sanction of the Lieutenant Governor is hereby accorded for incurring an expenditure not exceeding Rs. 4,84,352/- (Rupees Four lakhs Eighty four Thousands three hundred and fifty two only) towards engagement of 11 nos. of Watch and Ward Security for carrying out various works like watch and ward security and various other works of this kind arise as and when in the premises as mentioned below for the period from 1.7.2018 to 31.10.2018 by M/s. Kalai Industrial Security Services, No.46, Arapani Avai Thottam, Uppalam Road, Nethaji Nagar III, Puducherry @ Rs. 11,008/-(Inclusive of EPF, ESI and GST) per person per month through GEM portal.
