NOTIFICATION

The Lieutenant Governor, Puducherry is pleased to enhance the financial assistance to Indigent Artistes from Rs.1000/- to Rs.1650/- , Rs.2200/-, /Rs.3250/- according to their age and to enhance the annual income ceiling limit to Rs.75,000/- and for the said purpose the scheme of Financial Assistance to Indigent Artistes performing Visual Arts in the Union Territory of Puducherry (hereinafter referred to as the said scheme) notified in G.O Ms No.32 and published in the Gazette of Puducherry is amended as under:

AMENDMENT

- (1)In clause 3 (e) of the said scheme for the words, figures and brackets, "The annual income of the applicant shall not exceed Rs.15,000/- (Rupees fifteen thousand only)", the words, figures and brackets, "The annual income of the applicant shall not exceed Rs.75,000/- (Rupees seventy five thousand only)" shall be substituted;
- (2) For the existing clause 4 in the said scheme, the following shall be substituted:-
- "The Indigent Artistes aged upto 59 shall be paid Rs.1650/- (Rupees one thousand six hundred and fifty only) per month; the Indigent Artistes aged between 60 and 79 years shall be paid Rs.2200/- (Rupees two thousand two hundred only) per month and the Indigent Artistes aged 80 years and above shall be paid Rs.3250/- (Rupees three thousand two hundred and fifty only) per month" and
- (3)In clause 7 (a) of the said scheme for the words, figures and brackets, "If the annual income of the recipient exceeds Rs.15,000/- (Rupees fifteen thousand only) the financial assistance will be stopped", the words, figures and brackets, "If the annual income of the recipient exceeds Rs.75,000/- (Rupees seventy five thousand only) the financial assistance will be stopped" shall be substituted.
- 2. The amendments at Sl.No.(1), (2) & (3) above shall come into force with effect from 01.05.2015.
