#### ORDER:

Sanction of the Lieutenant-Governor, Puducherry is accorded to the incurring of an expenditure not exceeding Rs.24,83,413/-(Rupees Twenty four lakhs eighty three thousand four hundred and thirteen only) towards payment of enhanced compensation to the Land Owner as awarded in the Court of the Principal District Judge at Puducherry in connection with the acquisition of land at Puducherry Revenue Village for the expansion of Bharathiar Memorial Museum-cum-Research Centre from the date of taking possession of the land to 30.06.2016 as detailed below:

Sanction of the Lieutenant-Governor is also accorded to draw the entire of amount of Rs.24,83,413/-(Rupees Twenty four lakhs eighty three thousand four hundred and thirteen only) as sanctioned in para 1 above, in advance by the Drawing and Disbursing Officer, Department of Art and Culture, Puducherry for payment to the above said Land Owner through the Deputy Collector (Revenue) North-cum-Land Acquisition Officer, Puducherry subject to rendering of accounts with the Directorate of Accounts and Treasuries, Puducherry as per rules.
