**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No.F.5/65-GP, dated the 11<sup>th</sup> January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the notification issued in G.O. Ms. No. 84 dated 6<sup>th</sup> September 1989 and published in Supplement to the Gazette No. 40 of the 3<sup>rd</sup> October, 1989 and the notification issued in G.O.Ms.No.3 dated 09<sup>th</sup> January 1992 and published in Gazette No.6, dated 11<sup>th</sup> February 1992 of the Education Department, Government of Puducherry and consequent to the bifurcation of Department of Art and Culture from the Education Department, Puducherry, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the Group 'C' posts of Museum Assistant in the Directorate of Art and Culture, Government of Puducherry, namely:-

1. *Short title and commencement.* (i) These rules may be called the Government of Puducherry, Directorate of Art and Culture, Group 'C' post of Museum Assistant [(Science)/(Humanities)/(Conservation)] Recruitment Rules, 2024.

ii. These rules shall come into force on and from the date of their publication in the official gazette.

2. *Application:* These rules shall apply to the posts specified in column (1) of the schedules annexed to this rules.

3. *Number of posts, its classification and Pay Level in the Pay Matrix.* The number of the said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedules annexed hereto.

4. *Method of recruitment, age limit and other qualifications.*- The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said schedules.

5. *Disqualification.*- No person,----

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor, Puducherry may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rule.

6. *Power to relax.* - Where the Lieutenant-Governor is of the opinion, that it is necessary or expedient so to do, he may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. *Savings.* - Nothing in these rules shall affect the reservations, relaxation in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes, Ex-servicemen and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.

A degree in Natural Science/ Physical Science/Ecology /Engineering from a recognized University/ Institution.
