### ORDER:

Sanction of the Lieutenant Governor is hereby accorded to incur an expenditure not exceeding Rs.4,22,334/- (Rupees Four lakhs twenty two thousand three hundred and thirty four only) towards the engagement of 11 nos. of Security Personnel for watch and ward duty in the premises of the Puducherry Museum, Bharathiar Manimandapam, Thiagi V. Subbaiah – Saraswathi Subbaiah Memorial Social, Scientific Literary Research Centre and Library, Bharathidasan Memorial Museum and Kizhur Monument for the period from 01.10.2016 to 31.03.2017 at the rate of Rs.6,399/- per person per month as detailed below from M/s. Kalai Industrial Security Services, No.46, Arapani Avai Thottam, Nethaji Nagar-III, Uppalam Road, Puducherry-1 on lowest quotation basis:

2. The workers shall be continued to be engaged for a period of 6 months with effect from 01.10.2016 to 31.03.2017 or till the necessity therefor ceases whichever is earlier and shall be paid at the rate of Rs.6,399/- (Rupees Six thousand three hundred and ninety nine only) per month per head.

3. Necessary agreement shall be executed between the Department of Art and Culture, Puducherry and M/s. Kalai Industrial Security Services, Puducherry for ensuring prompt service, and provision for performance guarantee and liquidated damages.

4. The expenditure is debitable to the Head of account "2205 - Art & Culture - 107 Museums - 107(02) Improvement to Museum/Research Centres & Strengthening of Nehru Science Centre - 107(02)(01) - Puducherry Region - (30) Other Contractual Services - Plan" in the budget.
