### ORDER:

Sanction has been accorded vide G.O. first read above for incurring of an expenditure for an amount of Rs.2,589/- (Rupees two thousand five hundred and eighty nine only) per month towards the payment of rent for continued occupation of the private building at Door No.157 A, First Floor, Main Road, Kurumbagaram, Karaikal for the period from 01.04.2013 to 31.03.2017. Monthly Rent for an amount of Rs.2,589/- for the period from 01.04.2013 to 31.03.2017 has not been paid due to paucity of funds and hence the said G.O. could not be operated in time. Hence, necessary revalidated expenditure sanction is required to settle the monthly rent charges for the above said period.

2. As per the I.D.Note/Memorandum No.G.24011/2/2017-18/F1(B), dt.08.12.2017 of Finance Department, instructions has been issued to merge the Plan and Non-Plan classification of expenditure. Whereas, the G.O. first read above, the expenditure sanction has been issued under the head "2205-Art & Culture-105-Public Libraries – 105 (02) – Branch Libraries – 105 (02)(02) Karaikal Region- (14) Rent, Non -Plan" in the budget and hence, it is now required to operate the sanction under the new head "2205-Art & Culture-105-Public Libraries – 105 (02) – Branch Libraries – 105 (02)(02) Karaikal Region- (14) Rents, Rates, Taxes" in the budget.
