Whereas, the G.O. first read above, the expenditure sanction has been issued under the head "2205-Art & Culture-105-Public Libraries 105 (02) Branch Libraries 105 (02)(02) Karaikal Region- (14) Rent (Non -Plan)" in the budget, and hence, the Corrigendum is issued to operate the sanction under the new head "2205-Art & Culture-105-Public Libraries 105 (02) Branch Libraries 105 (02)(02) Karaikal Region- (14) Rents, Rates, Taxes" in the budget.
